In consideration of the mutual promises herein, Participant agrees on his/her/its behalf, and on behalf of any Affiliates, to abide by the terms of the Intellectual Property Rights Policy of the CAB Forum (the "IPR Policy") v.1.0, incorporated herein by reference. Participant acknowledges that some of its obligations under the IPR Policy may survive the termination of this Agreement, as more fully described in the IPR Policy.

The party signing this Agreement intends that it shall take effect as an instrument under seal. If such party is not a natural person, the individual signing this Agreement for the Participant represents and warrants that he or she has the authority to enter into this Agreement on behalf of the Participant.

The Participant represents and warrants that either: (a) it has the authority to enter into this Agreement on behalf of all of its Affiliates; or (b) it has no Affiliates; or (c) each of its Affiliates has executed and delivered to the CAB Forum a countersignature to this Agreement, indicating that it consents to this Agreement, and agrees to enforce this Agreement's terms as to any of such Affiliate's Intellectual Property, including such terms as may properly be changed by the CAB Forum by notice to the Participant under this Agreement.

Furthermore, SwissSign is party to the CAB Forum IPR Policy Agreement ("Agreement") which refers to and incorporates the Intellectual Property Rights Policy of the CAB Forum ("IPR Policy) v.1.o. The CAB Forum will introduce the IPR Policy on 1 Aug 2012.

SwissSign is a subsidiary of Die Schweizerische Post, Viktoriastrasse 21, 3030 Bern, Switzerland ("Swiss Post").

The "IPR Policy" defines "Affiliate" in Section 8.3.a. and allows a Participant to exclude an entity from this definition, if the Participant files a Notice of Excluded Affiliate with the CAB Forum pursuant to Section 8.3.a.

**Now, therefore,** SwissSign herewith files with the CAB Forum a Notice of Excluded Affiliate pursuant to Section 8.3.a. of the IPR Policy, identifies the following entities as Excluded Affiliates:

- A. Swiss Post, Viktoriastrasse 21, 3030 Bern, Switzerland ("Excluded Affiliate A");
- B. **PostFinance AG**, Nordring 8, 3030 Bern, Switzerland ("Excluded Affiliate B");

- D. **any other Subsidiary of Swiss Post enlisted in Annex A** to this Notice of Excluded Affiliate ("other Excluded Affiliates") with the exception of SwissSign. Upon request by the CAB Forum SwissSign will provide an up-to-date list;

and represents to the CAB Forum, for the benefit of all implementers that: (i) the Excluded Affiliates are not a Browser or CA under the Forum's membership requirements; (ii) without requiring a patent search of the Excluded Affiliates' patent portfolios, the Participant does not have knowledge of an Essential Claim included in a patent or patent application owned by any of the Excluded Affiliates; and (iii) the Excluded Affiliates exist mainly for purposes other than to hold intellectual property rights.

SwissSign informs that the institution Swiss Post (Exclude Affiliate A) is scheduled to be converted into a public limited company under special law on 1 January 2013. The Definition of Exclude Affiliate A therefore includes the public limited company into which Swiss Post will be converted. All rights deriving from this Notice of Excluded Affiliate will be automatically transferred to the same legal subject in the new legal entity, in accordance with the law, and that this circumstance does not constitute grounds for extraordinary termination of this Notice of Excluded Affiliate.
